Eligible applicants include:

Category	Eligible Participants
<b>Large Industry</b>	Large enterprises sponsoring or funding research collaborations with Indian academic institutions
<b>MSMEs</b>	Micro, Small and Medium Enterprises supporting research, innovation, or technology partnerships with academia
<b>Academic Institutions</b>	Indian universities and higher education institutions partnering with industry and/or MSMEs
<b>Section 8 Companies</b>	Not-for-profit organisations engaged in research, innovation, and industry–academia collaboration

Category	Eligible Participants
<b>Research Institutions</b>	National laboratories and research organizations working with industry to translate research into application
<b>Centres of Excellence (CoEs)</b>	Specialized research or innovation centers collaborating with industry and MSMEs
